INVITATION TO TENDER FOR MAIL TRANSPORTATION SERVICES

The Postmaster General of Jamaica invites suitably qualified contractors to tender for the provision of mail service under the heading Mail Transportation Services at the Central Sorting Office (C.S.O) and other specified Post Offices island-wide.

Bidding will be conducted in accordance with the current guidelines stipulated in the Government of Jamaica Handbook of Public Sector Procurement Procedures.

Eligibility Criteria

Bidders must submit the following documentation along with their bids:

- **Copy of a valid Tax Compliance Certificate (TCC);**
- **Copy of a valid National Contract Commission (NCC) registration certificate in the category "Transportation and Haulage";**
- **A completed, signed and stamped Service Provider's Bid Form.**
- **A completed signed and stamped Qualification form**

Failure to submit the above stipulated document(s) or any document(s) requested in the tender document will result in the automatic disqualification of the bid.
