Exportation of Coffee

In keeping with the protocols of the Jamaica Agricultural Commodities Regulatory Authority (JACRA), the Post and Telecommunications Department wishes to advise/ remind persons that the maximum weight limit for roasted or soluble coffee intended for export without a permit is 5KG. If this weight limit is exceeded, a permit from JACRA will be required.

Additionally, unsealed packages containing coffee is to be presented to the Postal Clerk for inspection before they can be exported. Coffee intended for export must bear labels from one of the following licensed entities:
