The Post Corp was registered in 1995 and began operations in 2000. The company has been charged with transforming the Post and Telecommunications Department into a profitable, modern, digitally driven and efficient organization and a one stop hub for government services. Both entities operate under the Jamaica Post brand. The Post Corp is headed by the Postmaster-General/Chief Executive Officer, Mr. Lincoln Allen, JP, and over the years, the Post Corp has introduced various innovative services to meet the rapidly growing demands of the logistics industry, such as Zip Mail, Fast Track and Klick 'N' Ship.

Welcoming the new Board, Mr. Allen stated, "Jamaica Post remains focused on operational and financial transformation. As we move forward, we will take a structured approach to addressing key areas such as revenue growth, improving customer experience, digital integration, and product innovation.
